TERMS & CONDITIONS FOR AUCTION OF VEHICLE

- a) Interested parties may inspect the car on scheduled dates and satisfy themselves about the car they are bidding for. No test driving would be permitted.
- b) Acceptance of the terms & conditions in the bid form after inspection of the vehicle & the bid for auctioning should be addressed to The Estate Manager, IDSA, No 1, Development Enclave, Rao Tula Ram Marg, Delhi Cantt – 110010.
- c) Duly signed auction / bid document alongwith a self-attested copy of address proof must reach on or before the due date of submission. Bids received after due date and stipulated time due to any reason whatsoever shall not be considered.
- d) The reserve price of the Ambassador Car has been kept at Rs. 37,200/- as the vehicle is in running condition, serviced, with accessories and insured (comprehensive insurance) upto 06 May 17. No bid would be accepted below this price.
- e) IDSA reserves the right to cancel the auctioning without assigning any reason whatsoever.
- f) Bids without EMD shall not be permitted to participate in the bid / auction.
- g) The auction document should be duly signed (all pages) by the bidder along with the form of acceptance at Annexure 'B'.
- h) The bidder should quote the amount at Annexure 'C' in words and figures in Indian Rupees. In case, there is a difference between the amount as quoted in figures and words, lower of the two shall be considered.
- j) The car shall be sold to the highest bidder after opening the bids on Oct 20, 2016, 1530 hrs in presence of the bidders or their representatives.
- k) The car, once, sold to the successful bidder, shall not be taken back by IDSA, on any condition whatsoever. No refund / return permitted.
- l) The successful bidder has to make full payment in form of cheque on completion of the auctioning, in favour of IDSA, payable at New Delhi within five working days from bid result announcement. The vehicle shall be delivered on realization of the cheque. If the cheque fails to realise, the offer will be cancelled and EMD shall stand forfeited and next highest bidder would be considered.

m) The successful bidder shall be required to pick the car from the disposal site to his premises within three days after the realization of the payment at his own expense.

n) IDSA representative shall submit application to the concerned Transport Authority in prescribed form for transfer of vehicle in presence of the representative of the bidder within 10 days after the delivery date of the vehicle. The buyer shall submit a copy of registration certificate at IDSA within one month after the date of submission of papers to the Transport Authority. All the cost for transfer will be borne by the purchaser.
