The interested bidders are advised to register themselves with e-procurement Portal at - <https://www.tcil-india-electronictender.com> to participate in the e-Tender. The bidders should upload duly signed tender form and their bids along with scanned copies of all the relevant certificates, documents etc. in support of their technical & price bids on the <https://www.tcil-india-electronictender.com>, latest by 04 July 2018 upto 14:30 hrs. Hard copies of the relevant documents need not be submitted except for (1) Demand Draft of Rs. **10000/- (Rupees Ten Thousand Only)** in favour of “**IDSA**” payable at New Delhi as **Earnest Money Deposit** and (2) **PASSPHRASE** for Tender opening event, which shall be submitted in sealed cover and dropped/ (send by speed post) addressed to the **Estate Manager, Institute for Defence Studies and Analyses**, may be sent at the Institute’s address mentioned above either by Speed Post / By hand delivery at Tender Box kept at the reception office, should reach on or before 04 July 2018 upto 14:30 hrs, duly mentioning on top right hand corner of the sealed envelope “**EMD/PASS Phrase for Supply, Installation and Testing of 400 Ltrs per Hrs capacity RO Plant at IDSA**”. The time allowed for Execution of work is 45 days from the issue of work order.

Reputed Manufacturers or their Authorized Dealers of RO plants should have the following requirements to make them eligible to qualify in the technical bid.

- a) Reputed Manufacturers or their Authorized Dealers should have satisfactorily completed **three similar works** (at least one of them in Central Autonomous Body/Central PSU/ Central Undertaking Body/ /Educational Institute). Three similar works each of value not less than 3 lakhs or two similar works each of value not less than 4 lakhs of estimated cost or one work of value not less than 6 lakhs in last 5 years ending last day of the month previous to the one in which the bids are invited.
- b) Should have average **annual financial Gross turnover not less than Rs. 25 Lakhs** during the **last three years** ending **31st March 2017**. Copy of Audited Financial Statements to be provided.

- c) **Similar or Similar Nature of work means** Supply and installation and testing of minimum 400 lit. Per hour capacity of R.O. Plant in any Government Department/Educational Institute.
- d) Manufacturer Authorization letter is to be furnished with the tender if authorized dealer of the manufacturer is participating in the tender on behalf of Original equipment Manufacturer.
- e) Contractors empanelled with DRDO /CPWD/MES/P&T are also eligible subject to they have completed at least one similar nature of work and fulfill the financial criteria.

All tenderers are requested to read the tender documents carefully **from Annexure I to VI** .The tender form and tender assessment criteria are slightly different from the routine tenders. If any information furnished by the applicant is found to be incorrect at a later stage, he shall be liable to be debarred from tendering/taking up of work in IDSA. IDSA reserves the right to verify the particulars furnished by the applicant at our end independently.

IDSA reserves the right to accept or reject any or all quotations including the lowest bidder without assigning any reason at its sole discretion and the decision of the IDSA will be final and binding to all concerned.
