those at which cultural and intellectual matters are discussed. They are expected to so conduct themselves that no doubts can be raised about their judicial detachment. Here the arrangement is between two cultural organizations—Kerala State National Council of ISCUS and Kazakh Society of Friendship and Kazakh Dept. of the Society of Soviet-Indian Cultural Relations.]

## UNDISPOSED STOCKS WITH S.T.C.

- \*656. SHRI ABID ALI: Will the Minister of FOREIGN TRADE be pleased to refer to the reply to Starred Question No. 111 given in the Rajya Sabha on the 24th July, 1969 and state:
- (a) when the last stock verification of accumulated stocks with the State Trading Corporation was done and for what amount shortage was found;
- (b) what was the value of the stock that remained unsold for more than six months; and
- (c) the steps that are being taken to realise the money involved in un-useable stocks?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (CHOWDHARY RAM SEWAK): (a) The last stock verification was carried out by the Corporation on the 30th September 1969 in respect of agricultural products and engineering goods and the shortages which were negligible ranged from 0.3% to 6.2%. The verification of entire stocks of the Corporation was carried out in February 1969 but the value of the stocks found short has not yet been worked out for all thei tems.

- (b) Rs. 14.04 crores, as on 30-9-69.
- (c) All tocks are in useable condition and efforts are being made to liquidate them.

# Nuclear Non-Proliferation Treaty

- \*657. SHRI KRISHAN KANT: Will the PRIME MINISTER be pleased to state:
- (a) whether Government propose to utilise the options available by not signing the Nuclear Non-Proliferation Treaty; and
- (b) if so, the manner in which they propose to utilise them?

THE PRIME MINISTER (SHRI-MATI INDIRA GANDHI): (a) and (b) Government's policy both on the Non-Proliferation Treaty as also on the utilisation of atomic energy for peaceful purposes, has been clarified and discussed at length in the House.
