## BENEFIT, RELIEF AND REHABILITATION OF RETIRED JAWANS

- 1473. SHRI JAGAT NARAIN: Will the Minister of DEFENCE be pleased to state:
- (a) the extent of benefit to which retired jawans of the Indian Army, Navy and Air Force are entitled;
- (b) the steps taken by Government to rehabilitate retired Jawans and provide them adequate employment;

THE MINISTER OF DEFENCE (SARDAR SWARAN SINGH): (a) Personnel below officer rank who become non-effective after completing 15 years or more of qualifying service (20 years or more in the case of Noncombatants Enrolled), are eligible for a service pension. The rates of service pension vary according to the rank, total length of service and the pay group of the individual on the date of becoming non-effective. The rates of service pension for the highest and the lowest pay groups on completion of the prescribed years of qualifying service for each rank are given in Statement 'A' attached [See Appendiv LXV, Annexure No. 115.]

(b) Details are given in Statement B' attached [See Appendix LXV, Annexure No. 116.1

(c) and (d) The information is being collected from the pension paying thorities and a statement will be on the Table of the House in laid due course.

INDIA'S FINANCIAL LOSS DUE TO CLOSURE OF THE SUEZ CANAL

## 1475. SHRI SITARAM JAIPURIA:

DR. (MRS.) MANGLADEVI TALWAR:

Will the PRIME MINISTER pleased to state:

- (a) the amount of financial loss to Indian interests as a result of the closure of the Suez Canal;
- (b) the steps taken to minimise the losses; and
- (c) whether there is any possibility for reopening the Canal in the near future?

PRIME MINISTER MINISTER OF EXTERNAL AFFAIRS (SHRIMATI INDIRA GANDHI): (a) While it is not possible to estimate the loss, India is incurring an additional expenditure of an estimated 22.5 million Rupees per month because of the higher freight charges which have to be paid for our imports from the West. Since statistics of freight paid on exports are not maintained, it is not possible to assess the additional expenditure incurred on our exports.
