

SUBJECT: QUOTATION FOR MISCELLENOUS FABRICATION WORKS-AT MP-IDSA

Terms and Conditions

Subhead: fabrication, Supply and Erection of Iron frame and fencing rods.

Quotations are invited for the work as per scope of work and terms & Conditions of the order shall be as follows: -

1. **Time Schedule:** The work shall be completed within 45 days from the date of placing of order. A sum of Rs 500 per day will be charged for delay in completion of work. Decision of Assistant Director in this regard shall be final and binding.

2. **Execution of Work:** The job work shall be executed in best workmanship like manner, to the entire satisfaction of the Assistant Director.

3. **Unit Price:** Unit rates quoted as per scope of work for the work shall be deemed to include all material, labour, tools and accessories, as required for proper execution of work complete in all respects. Any missing minor details which are not spelt out in the description of items but are required for proper completion of job work, shall be deemed to have been taken into account in the quoted rates. The rates shall also include for all taxes (except GST), including price escalations, contractor's overhead and profit. Nothing extra shall be admissible on any such account.

4. Earnest Money Deposit: Bidders shall deposit Earnest Money Deposit (EMD) along with their bids. While submitting the bid, the vendor shall deposit Earnest Money of Rs. 2000/- by demand draft "IDSA" payable at New Delhi. No other mode of remittance shall be accepted. EMD is to remain valid for a period of 90 days beyond the final bid is accepted. EMD of the unsuccessful bidders will be returned to them at the earliest latest on or before the 30th day after the award of the work. The EMD of the successful bidder would be returned, without any interest whatsoever, after the receipt of Performance Security from them as called for in the contract. EMD is not required to be deposited by those Bidders who are registered MSME, etc. The EMD will be forfeited if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity period of their tender. The bidders found without EMD are liable for outright rejection.

5. <u>Security Deposit</u>: On receipt of the Letter of intent (LOI), the successful bidder shall furnish 10% of the contract value as security deposit in the form of Fixed Deposit Receipt from Nationalized Bank or Bank guarantee from Nationalized Bank. The Security deposit shall be valid for a period of fifteen days beyond the defect liability period.

6. **Defect Liability: The** work completed shall have defect liability period of 12 months from the certified date of completion. The contractor shall re-do the work, wherein defects have developed during this period under the direction of the Assistant Director at no extra cost.

7. No material shall be issued by the department. All materials for the work shall be procured/arranged by the contractor at his own cost.

8 **Opening of Quotations:** Quotations shall be opened by the committee constituted by the Institute on 11th **Feb 2021 at 1030 hrs**.

9. Upon acceptance of the quote, no subletting/transfer would be allowed by the Contractor.

10. The quantities / scope of work can be increased or decreased by the Institute in any proportion /ratio for which the contactor will have no objection nor claim any compensation for which the contractor will have no objection nor claim any compensation and shall extend full cooperation to each other.

11. Wherever applicable, the contractor shall ensure that no damage is caused to the existing structure, floors of the existing building by him or his labour. In case of any damage caused, the contractor will have the same repaired at his own cost to restore it to the existing condition, clean all droppings, marks etc. caused on account of their working. He shall arrange to cover, existing works at his cost in such a manner they are protected from any damage.

12. No escalation clause shall be considered for any rise in material, labour or other inputs etc. etc. Similarly, no extra unit rate shall be considered in case of increase or decrease in quantity of individual items. The party shall have to complete the same with in the accepted rates.

13. Extension of time for completion of work shall not be granted except for natural calamities and other unseen reasons. For any damage or injury to any third party or labour is the sole responsibility of the contractor and the MP-IDSA is not responsible for any payment of compensation. The contractor is fully responsible of all such risks and compensation.

14. Complete work as per technical specifications should be completed within 45 days from the date of issue of order. If work is not completed within stipulated period then penalty Rs. 500/- per day basis delay subject to a maximum of 10% of total amount of the work order.

15. Payment Terms:

(i) No payment shall be made in advance or during work

(ii) Payment will be made on actual measurement basis.

(iii) No payment shall be made for goods rejected

(iv) EMD can be adjusted (released) against security deposit .

(v) 100% payment will be released after satisfactory completion of work after due deduction of statutory compliances like TDS, GST as applicable rules shall be made from the due payment of the bidder.

16. Timing of work : under Normal circumstances , the working Hours are 0900 Hrs to 1800 Hrs . If the bidders to intends to relax the timings, he shall inform the Estate cell . Permission shall only ne given after due approval of Assistant Director .

. Scope of work

Introduction : Manohar Parrikar Institute for Defence studies and Analyses , is a premire think tank in the area of Defence studies . The Institute is situated in Sharkar Vihar Area of Delhi Cantonment .

The scope of work includes procurement , fabrication, supply and erection of Iron Frame and Designed fencing rods .

Drawings are attached with this tender, these should be for general guidance of the contractor to visualize the type of work contemplated and scope of work. The contractor will be deemed to have studied the drawing and formed an idea about the work involved.

If any detail drawing required by the contractor, these shall be prepared by the contractor and the same shall be approved by the Institute's representative.

The works earmarked for this tender are as follows :-

(a) Iron Frame : Fabrication , supply and erection of Iron Frame :

Basement of Institutional building has been designed to use as a parking space . At the entrance of basement/parking. The existing iron frame has worn out and needs replacement .

(b) Fencing rods : There are 250 fencing rods are lacking from the peripheral wall and gate No 2 to transformer . Bidders are to procure, fabricate and erect the missing iron rods wherever required . The scope of work includes the caps to cover the base plate where rods are to be welded.

Bidders are requested to ensure that following services are to be provided

(i) Supply of required material

(ii) Testing of Material /structure ; MP-IDSA through its representative shall have free access at all times to those parts which are concerned with the fabrication of steel work and reserve the right to satisfying himself that the fabrication is being undertaken in accordance with th provision of specification and other relevant BIS Codes

(iii) Fabrication : Fabrication as per design and specification : fabrication of structure and rods shall be done in accordance with IS: 800, IS : 9595 and other relevant BIS codes . Any defective material used in the work shall be replaced by the contractor at his own expense . Necessary care and precaution shall be taken so as not to cause any damage to existing infrastructure . Any faulty fabrication pointed out at any point of time at any stage of the work , shall be good or replaced by the contractor at his own cost . Holes may be drilled in one operation and burrs removed from each parts after drilling .

(iv) Assembling and fixing in position .: Loading and transporting all fabricated steel work and field connection , material including side unloading is under scope of work .

(v) Load test

- (vi) Profile cutting of components
- (vii) Smooth grinding of edges /faces/all welding

(viii) Providing and applying primer and paint finish : the frame and fencing rods should be properly cleaned to remove dirt, grease, oil and loose mill scale and give one shop coat of Epoxy Primer. After erection one coat of epoxy polyurethane shall be applied. All paints shall be of Asian Paint /ICI/Berger/Nerolac or approved equivalent.
