Online Quotations are invited for the work as per scope of work and terms & Conditions of the order shall be as follows: -

- 1. **Time Schedule:** The work shall be completed within 15 days from the date of placing of order. A sum of Rs 1500 per day will be charged for delay in completion of work. Assistant Director, decision in this regard shall be final and binding.
- 2. **Execution of Work:** The job work shall be executed in best workmanship like manner, to the entire satisfaction of the Assistant Director.
- 3. **Unit Price:** Unit rates quoted as per scope of work for the work shall be deemed to include all material, labour, tools and accessories, as required for proper execution of work complete in all respects. Any missing minor details which are not spelt out in the description of items but are required for proper completion of job work, shall be deemed to have been taken into account in the quoted rates. The rates shall also include for all taxes (except GST), including price escalations, contractor's overhead and profit. Nothing extra shall be admissible on any such account.
- 4. Earnest Money Deposit: Bidders shall deposit Earnest Money Deposit (EMD) along with their bids. While submitting the bid, the vendor shall deposit Earnest Money of Rs. 10000/- by demand draft "IDSA" payable at New Delhi. No other mode of remittance shall be accepted. EMD is to remain valid for a period of 90 days beyond the final bid is accepted. EMD of the unsuccessful bidders will be returned to them at the earliest latest on or before the 30th day after the award of the work. The EMD of the successful bidder would be returned, without any interest whatsoever, after the receipt of Performance Security from them as called for in the contract. EMD is not required to be deposited by those Bidders who are registered MSME, etc. The EMD will be forfeited if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity period of their tender. The bidders found without EMD are liable for outright rejection.
- **Security Deposit**: On receipt of the Letter of intent (LOI), the successful bidder shall furnish 10% of the contract value as security deposit in the form of Fixed Deposit Receipt from Nationalized Bank or Bank guarantee from Nationalised Bank. The Security deposit shall be valid for a period of fifteen days beyond the defect liability period.
- 6. **Defect Liability:** The work completed shall have defect liability period of 12 months from the certified date of completion. The contractor shall re-do the work, wherein defects have developed during this period under the direction of the Assistant Director at no extra cost.

- 7. No material shall be issued by the department. All materials for the work including cement if required shall be procured/arranged by the contractor at his own cost.
- Bidder who has downloaded the tender /quotation from the Central Public Procurement Portal (CPPP) website https://eprocure.gov.in/epublish/app ,IDSA website and MSTC e-portal shall not tamper/modify the tender /quotation form including downloaded price bid template in any manner. In case if the same is found to be tempered/modified in any manner, tender will be completely rejected and EMD would be forfeited and Bidder is liable to be banned from doing business with IDSA.

- **10. Opening of Tenders:** Financial Bids will be opened online by the committee constituted by the Institute. All technically qualified Tenderers will be informed in advance the date of opening of financial bids in presence of their representative(s) if they wish to be present.
- 11. Upon acceptance of the quote, no subletting/transfer would be allowed by the Contractor.
- 12. The quantities / scope of work can be increased or decreased by the Institute in any proportion /ratio for which the contactor will have no objection nor claim any compensation for which the contractor will have no objection nor claim any compensation and shall extend full cooperation to each other.
- 13. Wherever applicable, the contractor shall ensure that no damage is caused to the existing structure, floors of the existing building by him or his labour. In case of any damage caused, the contractor will have the same repaired at his own cost to restore it to the existing condition, clean all droppings, marks etc. caused on account of their working. He shall arrange to cover, existing works at his cost in such a manner they are protected from any damage.
- 14. The price bid shall be on per square foot basis only. No Wastage shall be considered for measurement. The contractor shall include cost of supply & transportation of materials, labour, tools, etc. to the site. The price shall be inclusive of removing the existing carpet, chairs/desks, fixing and laying of new carpet and re-fixing of chairs/desks without damage any other existing fitting without any extra cost.
- 15. No escalation clause shall be considered for any rise in material, labour or other inputs etc. etc. Similarly, no extra unit rate shall be considered in case of increase or decrease in quantity of individual items. The party shall have to complete the same with in the accepted rates.
- 16. Extension of time for completion of work shall not be granted except for natural calamities and other unseen reasons. For any damage or injury to any third party or

labour is the sole responsibility of the contractor and the IDSA is not responsible for any payment of compensation. The contractor is fully responsible of all such risks and compensation.

- 17. Complete work as per technical specifications should be completed within 15 days from the date of issue of order. If work is not completed within stipulated period then penalty Rs.1500/- per day basis delay subject to a maximum of 10% of total amount of the work order.
- 18. Payment Terms: Payment will be made on actual measurement basis & 100% payment will be released after satisfactory completion of work. All statutory deductions like TDS, GST as applicable rules shall be made from the due payment of the bidder.
