NOTICE FOR SPOT AUCTION OF OBSOLETE STORE ITEMS AS SCRAP

A "Public SPOT Auction" of unused and obsolete store items belonging to MP-IDSA shall be held at 07.09.2026 on 1500hrs in the premises of the institute at basement from the authorized and eligible bidders on **"as is where is & what is basis"** at MP-IDSA premises located at No. 1 Development Enclave, Rao Tula Ram Marg, Delhi Cantt, New Delhi -110 010 . The details of the store items are as under:-

The terms and conditions for open auction are as under :-

1. The obsolete store items will be auctioned through "Public Auction" on "As is where is basis" by the Auction Team/Committee.
2. These obsolete store Items can be inspected on any working day between 1100 hrs to 1700 hrs.
3. Before participating in the public auction, the participant/intended bidder shall have to deposit earnest money of Rs 5000/- in demand draft of schedule bank in favour of MP-IDSA payable at Delhi. The demand draft of unsuccessful bidders will be returned after completion of Auction process.
4. The public Spot auction will be held on 07.09.2026 at 1500 hrs in the presence of participant/intended bidders.

5. In case of any holiday falls on 07.09.2026, the public auction will be held on to the next working day at the same time.
6. The auction received by DAK/FAX/Email or by any other mean, shall not be entertained.
7. The items shall be sold in complete single lot to the **H1 bidder** i.e. the bidder that offers Highest Price.
8. No conditional offer shall be accepted.
9. The highest bidder will have to submit proof of his/her identity (Copy of Aadhar Card/Voter Card or any other authentic proof) on the day of auction.
10. **Mode of Payment:** On receipt of the Letter of Award, the successful bidder shall be deposit 100% of the contract value in the form of DD from Nationalized Bank or NEFT within 10 days. The Security deposit shall be valid for a period of 30 days beyond the lifting of scrap period. Security deposit shall be returned within 10 days after successful completion of process.
11. The successful bidder will have to deposit the Entire Bid Amount Through "Demand Draft" of schedule banks.
12. The successful bidder will have to remove the obsolete store items at his own cost within 5 working days after depositing the entire bid amount.
13. The earnest money of Rs 5000/- will be returned on the same day to the unsuccessful bidders after closing the public spot auction.
14. Other terms & condition shall be declared at the time of open spot auction.
15. The auction committee/Team reserves the right to accept or reject the highest bid without assigning the reason.
16. If the highest bidder(s) failed to deposit the requisite bids amount at any stage, the earnest money shall be forfeited.
17. The earnest money deposited before the start of the auction shall be adjusted to the bid amount in case of highest bidder.
18. No claim for damage done by the way of theft, fire or any other unforeseen calamity will be entertained after realizing full payment against the unserviceable items.
19. Ground rent charge @ 1% of quoted amount per day will be charged if buyer fails to remove the lot within given time frame (7 days after award of work) as specified in

the office order. However, in case extra time is required, it shall be under the discretion of competent Authority.

20. The lifting of the items shall be done without damaging the premises roads drains etc. The buyer shall compensate the damages, loss etc, in the event of any occurrence otherwise. The buyer shall take the responsibility to set right any damages caused during lifting of the materials, to the satisfaction of the concerned authority.

21. No selection or sorting whatsoever of the goods will be allowed. The entire lot should be cleared by getting proper gate pass from institute.

22. All labour, tools and equipment for loading the items from site to buyer's trucks with all leads, lifts, etc. shall be at the cost of the buyer.

23. The buyer is subject to the security rule of seller in force while in the seller's premises. The purchaser/s, their workmen agents or representatives shall not commit any nuisance, theft or indulge in any antisocial activities in the seller's premises and the purchaser shall be liable for the good conduct, safety & discipline of his workmen. In case of any such activity, delivery will be suspended and strict action as per law will be taken including forfeiture of security deposit.

24. The institute will not at any time be responsible for any injuries caused due to accident within its premises either to the buyer or his representative/labour etc. and the buyer will make proper arrangements for any claim arising out of the employment under any statute. It is the responsibility of the buyer to provide necessary safety appliances (like hand gloves /safety shoes etc.) to the laborers, who are engaged for loading the materials, if required

25. If any theft/fire/damage or any type of mishappening occurs within the period of award of lot and removing of materials from institute premises the loss will be borne by the bidder. The institute will not be responsible for loss, damage or deterioration of the material due to any cause, whatsoever within the said time.

26. Any un-cleared or un-noticed materials left over by the successful bidder within the premises cannot be claimed later.

27. If the awarded lot is not removed it will be treated as abandoned lot and appropriate action will be initiated against defaulter for such abandoned lot. Institute reserves the right to re-sell abandoned lot. The concerned bidder will not have any claim whatsoever about the abandoned lot.

28. No enquiry of bidder shall be entertained once the material is lifted by them.

29. The materials being disposed are to be treated in line with applicable rules/notification/guidelines etc. as may be prescribed by the government. The successful bidder shall be responsible to ensure this action.

30. No GST invoice will be issued by institute against sale and disposal. GST or other taxes applicable shall be borne by the vendor.

31. Additional amount on total quoted scrap values as TCS (Tax collection at source) as per Income tax profit and gains from the business of trading in scrap rules shall be deposited by successful highest bidder.

32. The bidder may inspect the materials on any working day between 11:00 AM to 05:00 PM between 17.08.2026 to 31.08.2026, except Saturday and Sunday by prior appointment to satisfy themselves about the quality & condition of the materials offered. No complaint whatsoever will be entertained after the tenders are submitted or before or after the materials are lifted. No request for samples or inspection after submission of the tender will be accepted. In view of the 'as- is -where is & what is basis' condition bidders are advised to quote rates only after inspection of the items at the site.

33. Eligibility / Qualification Criteria:-

- i) The bidder should possess a registration as a firm under Proprietorship / Partnership or a firm, with any Government Authority. (Certificate issued by Shops and Establishment registration or Service Tax (GST) Registration or any other issuing Authority).
- ii) All bidders must enclose GST registration certificate along with the tender documents.
- iii) Copy of PAN
- iv) Copy of address proof
- (v) proof of scrap lifting from any organization.

Note: Bidder may inspect the Campus & assess its requirement before bidding.
